# Alerts Window Attributes

The attributes listed in the table below are applicable to both the CCAAdv and WA Alerts windows, with the exception of the Peripheral Offline column. This column is applicable to the CCAAdv **Alerts** window only.

	<b>Metric Threshold Violation Alerts</b>	<b>Peripheral Offline Alerts</b>	<b>Manual Alerts</b>
<b>Name</b>	<p>The display name of the metric threshold violation and its current value (in red [Critical], or yellow [Warning]).</p> <p>Hovering over a metric displays a brief description (this is the description configured in the <b>Report Metrics</b> page of the Administration module).</p>	Displays Peripheral Gateway Offline.	The message configured for the alert. The message is configured in the <b>Manual Alerts</b> page in the Administration module.
<b>Context</b>	<p>The scope of the metric; that is, geographic region, application group and contact center.</p> <p>The display format is: Geographic Region/Application Group/Contact Center/Base Object Name.</p>	Displays the name of the contact center and offline peripheral.	Displays the name of the contact centers associated with the alert. Because a manual alert can be associated with multiple contact centers, there are multiple entries in the <b>Alerts</b> window for a given manual alert, with one entry for each contact center.
<b>Metric Value</b>	The metric value.	Displays Critical.	<p>Displays Critical if the level of the alert (as configured in the Administration module) is 1.</p> <p>If the level is 2, the second line displays Warning.</p>
<b>Last Updated Metric Deviation</b>	<p>Displays the following three types of data in the format:</p> <p> 5 (50%)</p> <ul style="list-style-type: none"> <li><b>Value pointer</b>—An up arrow or down arrow, depending on whether the value has increased or</li> </ul>

<b>Sparkline</b>	<p>A graph appears in the expanded cell, showing the metric and alert activity from the time the sparkline is open.</p> <p>At each bar (time interval) a tooltip displays the date, time, and metric value.</p>
