# **About This Software**

The IVR Interface Option architecture simplifies the integration of vendor-provided IVRs with the Genesys environment. Genesys IVR Interface Option has two components, the IVR Server and the IVR Driver.

IVR Server is designed to:

- Provide a standardized interface between IVR drivers and other components in the Genesys product suite. This standard interface allows the IVR driver to use a one-socket connection and one type of interface to communicate with and receive services from different Genesys software components.
- Allow communication with several T-Servers simultaneously. This makes it
  possible to create flexible solutions in contact centers with complex setups.
  For example, one IVR system can be shared by several subscribers (tenants).

**IVR Driver** is the component of Genesys IVR Interface Option that provides integration with IVR vendor-specific hardware and software. From the IVR user's viewpoint, this is an additional set of functions that appear on the IVR user interface. The functions are used for script generation, to integrate an IVR with the Genesys environment.

For the 8.1 release, a separate single software CD is available that includes all vendor-specific Genesys IVR Drivers.

## New Features in 8.1.x

Release 8.1.0 includes the following features:

- Support for IPv6.
- Support for retrieval of AttributeThirdPartyDN.
- Configurable definition of return content for All: The previously existing call information of type All, may now be configured to also return either UUID and/or ThirdPartyDN.
- Support for Unresponsive Process Detection.
- Support for hiding user data within the logs.
- Support for new operating systems:
  - AIX 7.1 64-bit
  - Red Hat Enterprise Linux 5 32-bit and 64-bit
  - HP-UX Itanium (version 11i v3)
  - Windows Server 2008 R2

- vSphere 4 Hypervisor
- Discontinued support for operating systems:
  - Solaris 8
  - Red Hat Enterprise Linux version 3
  - HP Compaq Tru64 Alpha
  - AIX 5.1 and 5.2
