## **About This Software**

Genesys Network Media Interfaces contains the Genesys Network T-Servers software that allows the interconnection between any supported network component and Genesys solutions.

Genesys Network Routing can control, via the Network T-Servers, the calls that arrive on network components. Calls can be qualified, and then routed with attached data from the network component directly to the agent with the most skill to handle the call.

Network Media Interfaces is part of the package for the Genesys Network Routing Solution, which includes Universal Routing 8.1 and Management Framework 8.1.

## New Features in Release 8.1.x

The following new features were introduced in the May-2012 CD update for the 8.1.0 release:

### 8.1.0 Network T-Server for GenSpec

- New options, tid-min-value and tid-max-value, enable the specification of minimum and maximum DTID values, respectively.
- Limited display of sensitive information: In logs, new options enable sensitive
  data in logs to be marked for post-processing by the user, such as deletion,
  replacement, or hiding. See the Genesys 8.1 Security Deployment Guide for
  details.
- Compliance with FIPS: TLS as implemented by Genesys meets the Federal Information Processing Standards (FIPS).
- Network T-Server is now supported on the Red Hat Enterprise Linux 6 32-bit and 64-bit platform.

- Support for FLEXNet Publisher 11.9.
- Support for Red Hat Enterprise Linux 5 64-bit.
- Support for Windows Server 2008 64-bit.

- Support for vSphere 4 Hypervisor.

- Support for TCP/IP-v6.
- · Support for Unresponsive Process Detection.
- The maximal value of the expire option in the Log section has been increased.

### 8.1.0 Network T-Server for NGSN

- Network T-Server for NGSN has been enhanced to accept DNIS pool transfers.
- The number of call variables has been extended from 10 to 20.

### 8.1.0 Network T-Server for CRSP

Network T-Server for CRSP is now available at the 8.1.0 release level.

### 8.1.0 Network T-Server for ATT

Network T-Server for ATT now supports v9.1 of Natural Access Software.
